- 4) Refer to Article 12 of the Basic Agreement or Articles 11 and 12 of the Freelance Live & Tape Television Agreement for definition of salary and contribution ceilings.
- 5) **For all job categories except Directors, Employer Pension rate is 8.75% effective 7/1/25 (8.5% effective 7/1/21 to 6/30/25). For Directors, the pension contribution rate applicable to their services on a project is that in effect on the starting date of their employment on the project.**
- 6) When reporting Training Plan/Qual. List contributions, indicate the area ("L" for Southern California or "N" for Greater New York Area).
- 7) **For all job categories except Directors, Health rate is 11.25% effective 7/1/25 (11.0% effective 7/1/24 to 6/30/25, and 10.5% effective 7/1/13 to 6/30/24). For Directors, the health contribution rate applicable to their services on a project is that in effect on the starting date of their employment on the project.**
- 8) **Paid Parental Leave rate is 0.5% effective for work performed on or after 7/1/24.**
